Ōtira e te iwi, tēnā koutou, nau mai haere mai ki tēnei nohoanga o te Kooti Whenua Māori To all who are gathered here, welcome. Welcome to this sitting of the Māori Land Court.

Kua huakina ngā tatau ki tō tātau nei Kooti

Court is now in session

Ko te tono mātahi kei mua i te Kooti i te ata nei, Wiari Turangapito Tungane Peeti Whānau Trust, whakatū kaitarati hōu

The first application before the Court this morning is Wiari Turangapito Tungāne Peti Whānau Trust, appointment of a new trustee

Tēnā anō koutou, ko wai koutou?

Greetings to you. I will take appearances, who are counsel?
